1. M/s Perfecto Electricals, Trust House, 4th Floor, 32-A, Chittranjan Avenue, Kolkata - 700012 were served with a Memorandum and statement of charges/misconduct for banning of business dealings with them for securing tender case no. S&T/CON/87 dt 10.12.2008 for the work of "Panel Interlocking works in connection with Sitamarhi (excluding)-Raxaul - Narkatiaganj Gauge Conversion in Samastipur Division of E.C. Railway" by adopting unethical business practices.

2. Reply to the Memorandum submitted by M/s Perfecto Electricals, Trust House, 4th Floor, 32-A, Chittranjan Avenue, Kolkata - 700012 vide letter No. PE/2016-17/422 dated 29.08.2016 has been considered in detail by the competent authority who has concluded that M/s Perfecto Electricals, Trust House, 4th Floor, 32-A, Chittranjan Avenue, Kolkata - 700012 adopted unethical business practice for securing the tender case no. S&T/CON/87 dt 10.12.2008 in its favour by bribing a public servant, who was the then Convenor of Tender Committee, thereby causing wrongful loss to Railway.


3. It has, therefore, been decided by Ministry of Railways (Railway Board) to ban business dealings with M/s Perfecto Electricals, Trust House, 4th Floor, 32-A, Chittranjan Avenue, Kolkata - 700012 and their allied/sister concerns/partners for a period of five (5) years commencing from 23.04.2018 by Indian Railways and Production Units etc.
